Dear Chief Gillespie,

Clark County's General Fund is forecasted to have a deficit for 2017-2018. In response, the county manager has asked each department and office to provide expense reductions and/or revenue increases equal to 10% of their current budgets.

The Auditor's Office has provided Accounts Payable and Payroll services for other governments and agencies at no cost to them. We have not charged for these services because it has benefited tax payers as these other governments and agencies have not had to invest in the systems and staff necessary to carry out these functions.

However, as part of the solution to balancing the General Fund Budget, I have informed the county manager that effective January 1, 2017 we would be willing to begin charging for services we provide to other governments and agencies. I am not pleased to have been placed in this position.

If the final adopted budget includes this provision and you choose to continue to have the Auditor's Office provide services, the cost will be the same that county departments and offices are charged per the county's Indirect Cost Plan. This federally approved plan is updated annually using the costs and transactions of the prior year. For 2017, the estimated charge per Accounts Payable transaction will be \$8.71 and the annual cost for payroll per W-2 issued is estimated to be \$154.04. For 2017, your total expense is estimated to be \$16,776.75.

These charges will be billed once a year in November. We are willing to bill more frequently, however the cost of that additional service will be \$25.00 per billing.

- 9. Other Clients. \_(Contractor)\_retains the right to perform services for other clients.
- 10. **Equipment and Supplies**. \_(Contractor), at their own expense, will provide all equipment, tools, and supplies for all work necessary to perform the above services.
- 11. **Insurance and Certifications.** (Contractor) shall supply East County Fire & Rescue with certificate of insurance and all necessary certifications associated with \_\_\_\_\_\_ service.
- 12. Harassment and Legal Compliance. East County Fire & Rescue maintains zero-tolerance policies relating to harassment, bullying, sexual harassment, drug and alcohol consumption, and tobacco use. (Contractor) shall comply with all aspects of such policies while working on any East County Fire & Rescue property.
- 13. Confidentiality. \_(Contractor) acknowledges and understands that in the course of carrying out and performing its professional services to ECFR, \_they may have access to and will be entrusted with, detailed confidential information relating to East County Fire & Rescue-door codes etc. The disclosure of any such confidential information would be highly detrimental to the best interests and security of ECFR.
  - Accordingly, \_(Contractor) acknowledges, covenants and agrees that it will maintain the confidentiality of all such information, and that he/she will not disclose any such detailed confidential information to any person, firm or corporation, nor shall use, directly or indirectly, the same for any purpose other than for the purposes as stated herein in section one (1) Services to be Performed nor will it disclose for any purpose, other than stated herein, the affairs of ECFR or any other information which it may acquire during the term of this Agreement.
- 14. Hold Harmless. (Contractor) agrees to protect, defend, indemnify, and hold East County Fire & Rescue, its officers, commissions, employees, and agents free and harmless from and against any and all losses, penalties, damages, settlements, costs, charges, professional fees or other expenses or liabilities of every kind and character resulting from the error, omission or negligent act of (Contractor), its agents, employees, or representatives, in the performance of duties under this agreement. (Contractor) specifically promises to indemnify East County Fire and Rescue against claims or suits brought under Title 51 RCW by its employees or subcontractors. (Contractor) further agrees to fully indemnify East County Fire and Rescue from and against any and all costs of defending any such claim or demand to the end that East County Fire and Rescue is held harmless therefrom. This paragraph shall not apply to damages or claims resulting from the sole negligence of East County Fire and Rescue.
